On Election Day there will be 1 strategically located Voter Service and Polling Center in Las Animas County. A Voter Service and Polling Center is designed to provide voters with maximum flexibility and convenience. Voters may go to this Voter Service and Polling Center in the county to cast their ballots. Precinct specific polling places will not be used. At the Voter Service and Polling Center you will be required to show valid ID such as a driver's license.

We will begin mailing ballots out the week of October 10, 2025. The last day that ballots will be mailed out is Monday October 27, 2025. Ballots may be mailed or deposited at the Ballot Drop-off Locations. Ballots must be RECEIVED by 7:00 P.M. on Election Day, Tuesday, November 4, 2025. POSTMARKED DATES DO NOT COUNT AS RECEIVED.

REFERRED BALLOT MEASURE 4A:

SHALL AGUILAR REORGANIZED SCHOOL DISTRICT NO. 6 DEBT BE INCREASED BY \$2.7 MILLION, WITH A REPAYMENT COST OF NOT TO EXCEED \$5.3 MILLION, AND SHALL DISTRICT TAXES BE INCREASED NOT MORE THAN \$240,000 ANNUALLY FOR CAPITAL NEEDS OF THE DISTRICT INCLUDING:

- PROVIDING MAJOR RENOVATIONS TO THE CURRENT K-12 SCHOOL FACILITY, INCLUDING:
 - RESTORING THE HISTORIC GYM TO CURRENT SAFETY AND COLORADO HIGH SCHOOL ACTIVITIES ASSOCIATION STANDARDS;

- REPLACING THE SECONDARY SCHOOL ROOF:
- CREATING A SAFETY CORRIDOR CONNECTING THE MAIN SCHOOL BUILDING TO THE GYM WHICH CORRIDOR WILL INCLUDE NEW LOCKER ROOMS AND CONCESSIONS:
- REMODELING TO CREATE A SPACE FOR TRADES PROGRAMMING (WELDING, AUTO, FFA, CONSTRUCTION), REPLACING NON-FUNCTIONING HVAC AND FIRE ALARM SYSTEMS, REMODEL OF THE MAIN ENTRY TO MODERN SAFETY STANDARDS FOR STUDENTS AND STAFF;
- PROVIDING MATCHING MONEY REQUIRED BY THE STATE FOR THE DISTRICT TO RECEIVE A "BEST" GRANT IN AN APPROXIMATE AMOUNT OF \$13.4 MILLION (WHICH GRANT IS NOT REQUIRED TO BE REPAID BUT WHICH IS CONTINGENT UPON THE DISTRICT'S ABILITY TO PROVIDE THE MATCHING AMOUNT OF APPROXIMATELY \$2.7 MILLION);

PROVIDED THAT NO BONDS WILL BE ISSUED UNLESS A "BEST" GRANT IS RECEIVED; AND

FURTHER PROVIDED THAT THE ANNUAL TAX INCREASE SHALL NEVER EXCEED \$240,000 SPECIFIED ABOVE; AND

SUCH DEBT TO BE EVIDENCED BY THE ISSUANCE OF GENERAL OBLIGATION BONDS WHICH BEAR INTEREST, MATURE, ARE SUBJECT TO REDEMPTION, WITH OR WITHOUT PREMIUM OF NOT MORE THAN 3%, TO BE ISSUED AT SUCH TIME, AT SUCH PRICE (AT, ABOVE OR BELOW PAR) AND IN SUCH MANNER AND CONTAINING SUCH TERMS, NOT INCONSISTENT WITH THIS BALLOT ISSUE, AS THE BOARD OF EDUCATION MAY DETERMINE, AND SHALL AD VALOREM PROPERTY TAXES BE IMPOSED WITHOUT LIMIT AS TO RATE TO GENERATE AN AMOUNT SUFFICIENT IN EACH YEAR TO PAY THE PRINCIPAL OF, PREMIUM IF ANY, AND INTEREST ON SUCH DEBT OR ANY REFUNDING DEBT, OR TO CREATE A RESERVE FOR SAME?

SUMMARY OF WRITTEN COMMENTS FOR BALLOT ISSUE 4A:

Address Critical Facility Needs Now, Before Costs Escalate:

The school's roof and the aging gymnasium are in disrepair. Deferring these major repairs will only make them more expensive in the future as construction costs rise and damage worsens. Passing the bond now allows the district to act proactively and save taxpayers money long-term.

Protect Property Values and Community Pride

Strong schools help protect and sustain property values in Aguilar. Investing in safe, modernized facilities shows pride in the community and safeguards what local families have worked hard to build.

Prepare Students for Good-Paying Careers Through CTE

Updated facilities will allow the district to expand and strengthen career and technical education (CTE) programs. This equips students with practical skills—such as construction, healthcare, technology, or business—that lead to stable, well-paying jobs and keep opportunities close to home.

Create Safe, Functional Learning Environments

A roof that leaks and facilities that are outdated directly disrupt learning and create unsafe conditions. The bond ensures students have a secure, healthy, and functional school environment so teachers can focus on instruction, not maintenance issues.

Invest in the Future of Aguilar

Every dollar invested in schools is an investment in the community's future. By modernizing facilities now, Aguilar strengthens its tradition of supporting local families and ensuring students have the best chance to succeed.

SUMMARY OF WRITTEN COMMENTS AGAINST BALLOT ISSUE 4A:

Increased Property Taxes

Bonds are typically repaid through increases in property taxes, which can place a financial strain on homeowners and landlords (and potentially renters via passed-on costs).

Long-Term Debt

School bonds are usually repaid over decades (20-30 years), committing the community to long-term debt, even after current students have graduated.

Potential Decrease in Housing Affordability

Rising property taxes and better facilities can discourage new homebuyers.

Negative Perception in Divided Communities

If there's strong opposition, the bond may divide the community politically or socially.
