- NAICS Code - indicating an eligible industry.
- Affirmation of an intent to continue operations in Las Animas County for at least six months.
- Valid business license in good standing.
- Affirmation that the business has received no other funds from this special legislation (arts or minority business program)
- Evidence that the business is either a sole proprietor or has at least one full-time employee.
- Affirmation that the business is in compliance with all public health orders.
- Evidence that the business had less than 2.5 million in sales in 2019
- Profit & Loss Statement for 2019 and 2020 Comparison
- W-9.
