*Las Animas County grants the applicant a right-of-way under and/or along said road, to place, maintain and operate said pipeline for the transmission of \_\_\_\_\_ (water, gas etc) pipeline dia. \_\_\_\_\_ (inches)*

**It is understood:**

- Pipeline shall be buried at a depth determined by the County that being \_\_\_\_\_
- A clear zone of 10' minimum must be maintained from the County Road ditch's flow line or shoulder if no ditch exists, to any and all above ground structures, poles etc.
- Las Animas County reserves the right to require boring for pipeline installation
- Las Animas County reserves the right to require for backfill material 3000 psi concrete from road surface elevation 18" in depth into trench - entire road width
- The applicant will install said pipeline by machine, hand or other approved method.
- The applicant shall restore the road and right-of-way to their original condition. This original condition will be maintained by the applicant against settlement, wash outs etc. for a period of one (1) year from the date of the final inspection. In the event it is necessary to remove or relocate the line because of construction or any other reason, expense shall be absorbed by the applicant.
- Las Animas County is granting a license and not an easement. This license is irrevocable as long as the pipeline is used for transportation of the product originally permitted to transport.
- The Applicant will maintain the installation at all times. Las Animas County, agencies thereof, officers and employees will be held harmless from any and all claims, loss and damage which may arise out of or be connected with the installation herein referred to or any work of facility connected therewith, within the area covered by this license to the extent of the negligence of the applicant, their agents, servants or employees.
- For any trench (ripped or otherwise) that is wider than 12", the backfill shall consist of approved materials uniformly distributed in layers brought up equally. Once the backfill level is above the pipe, each layer shall not exceed 12" before compacting to the required density and before successive layers are placed. Backfill shall be compacted to a density of not less than 95 percent of maximum density determined in accordance with AASHTO T 180.
- A Traffic Control Plan, developed by a certified traffic control supervisor, will be submitted for all work performed within County road rights-of-way, or that will directly affect the travelling public. The County may choose to approve a contractor's developed and submitted Traffic Control Plan. All components of the plan must conform with all applicable portions of the latest edition of the Manual on Uniform Traffic Control Devices. Contractor must keep at least one lane of traffic open unless otherwise approved by the County. If the County Road approves of the closure of a County road while the installation is taking place, the applicant must contact Emergency Services and any other agency that might be affected by the closure including school districts.
- Applicant shall be responsible for any damage and associated repairs to the County Road and utilities
- This permit is not valid until it is signed by a duly authorized representative of Las Animas County

Colorado State Law requires that anyone who engages in any type of excavation must notify underground facility owners. Applicant may also need to join the Colorado utility notification center.
