OTHER INSPECTIONS AND FEES

The life of a building permit is one (1) year. If no work has commenced in 180 days, the permit becomes null and void and another permit is required. A permit may be extended, if construction has started, for two (2) additional periods providing the applicant submits a letter to the Building Inspector requesting an extension and construction has started. Extended permits are good for 6 months each.

** Additional amount will be charged to the base fee depending on the completeness of the drawings.
